- 4. *Resolved,* That the Fairmont State Board of Governors approves the Financing Plan to use existing tuition and registration capital fees, to be reimbursed from bond proceeds, for the funding for renovation of the Turley Center facility and to work with the Braxton County School Board for an addition to Braxton County High School. Motion carried.

Motion carried.
