Jason Pizatella called the December 5, 2024, Enrollment, Housing & Student Life Committee meeting to order at approximately 9:04am.

# **Fall Housing Applications**

- Returning students and newly enrolled students applications received for Fall 2025 632;
  up from 584 for Fall 2024
- Fall 2024-Spring 2025 current occupancy to date 890 students
- 5-year Housing Rates (handout) show a 4% increase for 2025
- The 4% increase covers early move-ins, students staying over break, etc. which assists with rising labor and utility costs in the residence halls.
- Summer is a separate term; students staying for the summer will move into 1 central hall; the other halls will be used for camps and conferences.

#### **Student Affairs Staff Development**

- ½ day in service for Student Affairs Staff
- Staff completed Clifton Strengths Finder
- Able to begin to create culture for the department & a common vocabulary with shared experiences

# **Holiday Facility Schedule**

- The number of students who stayed on campus over Thanksgiving break is up from last year; students will not be charged to stay in the residence halls this semester.
- Alladin (Jeff Swaim) offered dining times for students who remained on campus in the cafeteria.
- The Campus Recreation Center (Spencer Flanagan/J,R. Lowery/ Heidi Hormell) was able to open due to students wanting to work over break so that others were able to use the facility.

### **Fall Welcome Week Planning**

- Initiative to increase engagement, connections, & foundations for FTFs and transfer students
- Cross departmental planning has begun around campus for this event.
- 5 weeks after classes begin students will revisit the educational foundations laid during Welcome Week.

#### **Spring Enrollment Update**

- 25% increase in admissions for Spring 2025 Commitments
- A Foundation Scholarship was identified to help students with balances pay them off.
- Current Increase for Spring Enrollment Predicts 2,400 Students

#### **Spring Enrollment Update**

- Making strides in the past 4 weeks with new recruitment strategies in place for recruiters to implement
- Early in the process name buys, marketing strategies, and school visits are increasing both in and out of state

# **Fall Recruitment Update**

- Deposits are up but applications and admitted students are down
- Recruiters will be taught strategies to make them more aggressive in their approach to brining students to campus
- Software and platforms being optimized for full digital
- Fall to Spring Retention Rate will be targeted to slow/stop the attrition rate for students who leave
- 500 total students visited campus in November
- 115+ students attending December SOAR Event on campus
- Optimizing Financial Aid to connect the value of Fairmont State university to the monies students are awarded which will leverage aid to grow enrollment & build revenue
- Creating a seamless application experience
