Call to Order

Gina Fantasia called the August 12, 2024, Bylaws Committee meeting to order at approximately 9:01am.

- Gina Fantasia welcomed new Vice Presidents George Wolf (VP of Enrollment Management) and Dr. Janna Bredeson (VP of Student Affairs), as well as newly appointed Board of Governor members Lance Puccio and Drew Paton.
- For the benefit of new members, Gina Fantasia provided an overview of the Bylaws Committee's role in developing and overseeing Board policies and discussed HEPC Series 4 rule which outlines and implements statutory rulemaking policies and procedures in keeping with the Board's oversight responsibility.
- Gina Fantasia provided on overview of the activity of the Bylaws Committee during the 2023-2024 academic year, including its recognition that many of the existing policies need to be reviewed, reconsidered and revised; vacating a number of out-of-date policies that are no longer relevant since the formal separation from Pierpont Community and Technical College; and the Committee's agreement with the administrative suggestion that revision of Policy 50 "Policy on Policies" was the logical starting point for a robust policy review since Policy 50 sets out the process by which we adopt, change, or vacate policies.
- Gina Fantasia also reported that, to better inform the Committee's and the Board's work on policy revision, the Committee had asked that arrangements be made to have Kristin Boggs, General Counsel at West Virginia Higher Education Policy Council, provide

- training on "Roles and Rulemaking." That training is scheduled to occur immediately after the August 28^{th} Board of Governors meeting.
- Brian Selmeski noted that attendance in the Boggs training will count towards Board members' annual training requirement.
- Committee discussion ensued related to the Series 4 guidance that Board policies should encompass university-wide matters and administrative policies should address day-to-day operations. The Committee discussed the need for a collaborative process, and to work with the administration to prioritize policy revision.
- President Davis reported the University of Policy Committee has been established; however, he cannot issue any administrative policies until the Board revises Policy 50. Dr. Davis indicated he plans to update the Committee regularly on that campus committee's activity.
- Given the number of policies in need of review, the Committee discussed and reached
 the consensus that the Bylaws Committee will meet monthly. Gina Fantasia discussed with
 the Committee the plan that any draft policies will be shared with the Committee in
 advance to allow discussions and the exchange of comments, concerns and suggested
 revisions as the Committee finalizes drafts to be presented to the Board for consideration.
- Brian Selmeski indicated that, per the May 28, 2024, Bylaws Committee meeting, Legal Counsel had drafted recommended revisions to Policy 50 for discussion. Gina Fantasia asked that the draft be sent to her so she could share it with the Committee for review.
- Brian Selmeski reported the Board has sixty policies, plus the resolution on delegation of authority. The oldest of these was published in 2001, the newest was published this year, and two are not dated.
- President Davis recommended that while the Committee works on Policy 50, the
 Administration categorize the remaining policies into those that are (1) good-to-go, (2)
 those that should be updated, (3) those that should be vacated and become
 Administrative Policies, because they deal with day-to-day operations, and (4) those that
 will require both a Board and an Administrative policy. The Committee agreed that would
 facilitate its prioritization of its policy revisions.
- Gina Fantasia discussed Policy GA-07, "Rule Regarding Alcohol and Other Drugs." She
 reported that the Committee had previously accepted a revised policy, and
 recommended it to the Board, which put it out for public comment. Gina Fantasia
 reported that no public comments were submitted. The Committee reached consensus

that Policy GA-07 will be added to the BOG agenda for action on the August 28, 2024, BOG Meeting.
