There is no net gain or loss in hours as a result of this change. There is no change in the curriculum or the nursing or support courses. This proposal only affects admission criteria.

#### III. RATIONALE FOR THE PROPOSAL.

Currently, the admission criteria states that, for the BSN Program, students must have an active, unencumbered nursing license. In current practice, however, ASN graduates are admitted to the BSN and may take BSN courses without a nursing license in the following circumstances.

• They are taking general studies courses.

• They are taking NURS 3320 and/or NURS 3340 (a license is not required for those courses). This proposal would change the wording of the admission requirements to accurately reflect this practice. The licensure would become the prerequisite for nursing courses 3350 and above.

Students in the FSU ASN Program who have completed the first year of the program can also take the general studies courses, NURS 3320, and/or NURS 3340. As a result of this proposal, the ASN students who were pursuing any of those courses would be able to apply to the BSN Program and pursue both degree programs at the same time.

The new application/admission wording for the catalog would be:

"All applicants seeking admission to the Bachelor of Science in Nursing Program are required to:

- 1. Meet the general admission and course placement requirements of Fairmont State.
- Submit an application for admission, designating the major as Baccalaureate in Nursing, to the Director of Admissions. Official college and/or diploma program transcripts, including graduation date and degree, must also be submitted by the admission deadline established by the University.
- 3. Have transfer courses evaluated by the Registrar.

4. Submit all documents listed in the Program Health Requirements Policy; such as nursing licensure, background checks, drug screens, immunization records, CPR cards, and proof of immunity prior to program deadlines."

We know that some of our students, including the PROMISE scholarship recipients, come into the ASN Program with BSN credits (general studies) or begin pursuing the BSN upon admission to the ASN Program. To allow them to enroll in both programs at admission (to accurately portray the degrees the student is pursuing), a direct admission option will be created. The wording for this options would be as follows:

"Students with an overall cumulative GPA of 3.0 or higher and an overall ACT of 22 or higher are eligible for direct admission into the BSN Program concurrently with admission to the ASN Program but would have to apply for both degree programs. ASN students in good standing may also apply for admission to the BSN Program."

The overall effects of this proposal would be as follows:

- Accurate description of admission requirements and practices
- Ability of graduates to be enrolled in the ASN and BSN degree programs
- Accurate identification of the degree programs pursued by each student for retention tracking and financial aid purposes
