D.D. Meighan (December 31, 1944-June 23, 2025) was a community leader, volunteer, and social justice advocate. The TV station he managed, TV-19, was involved in community affairs, as well as local announcements in Fairmont, Morgantown, and Clarksburg WV. This public access channel televised Marion County meetings and events. The materials in this collection include CDs of recorded programs and DVDs of filmed events. There are about 500 CDs of recorded programs, and about 50 DVDs of filmed events. The events and programs televised include election interviews, sports announcements, community affairs such as charity banquets and weather-related disaster response, and much more.

Arrangement Description

This collection is arranged firstly chronologically and secondly numerically. Every CD is titled with each major program as well as program number. Every DVD is labeled with the event name. This collection was processed on an individual program basis. Each CD houses between 2-3 major programs, recorded monthly for each subsequent year, and each DVD a film of a major event.

The purpose of Blueprint Community is to develop livable communities in Fairmont while utilizing adaptive reuse of buildings. Much of what was proposed in 2007 has been implemented but much hasn't. A restaurant has been added, parking has been increased, apartments have been developed, and some buildings have been re-adapted for us (old Cook Hospital and former Board of Education facility).

EDITH ROBERTS A-4, Feb. 2009 speaks at Fairmont State, Sept. 8, 2008- 50:35

Edith Roberts, wife of George "Spanky" Roberts, speaks of her life and life with husband George "Spanky" Roberts. Edith was born in West Virginia and attended elementary schools in West Virginia, Pennsylvania, and New York. She graduated from West Virginia State University (formerly West Virginia State College) with a B.A. in Music (Vocal and Choral Conducting) and French. Married on the Air Base at Tuskegee March 7, 1942, Edith spent many years living on numerous Air Force bases in the United States and Japan as her husband served as a Black Senior Officer. She has many honors; including awards for preserving the legacy of the Tuskegee Airmen and for being the first African American social worker for the Sacramento School District. She was proud of her husband's achievements. The 450 Tuskegee Airmen assigned to the African/European Theater flew 1578 missions - 15,553 combat sorties while fighting the Germans, both in North Africa and Italy; the unequaled record of not having lost a single bomber, while they were escorting, due to enemy aircraft action. He became the first Black to command a racially mixed unit in the Air Force in 1950; director in Okinawa of all materials and responsible for 800,000 jobs. In 1965 he became responsible for all freedom fighter bombers in the world.
