



National Endowment for the Arts: Research Grants in the Arts

Posted: February 20, 2025

This program funds research studies that investigate the value and/or impact of the arts, either as individual components of the U.S. arts ecosystem or as they interact with each other and/or with other domains of American life.

Proposals Due: March 24, 2025

Funding Range: \$20,000 to \$100,000

National Endowment for the Arts: NEA Research Labs

Posted: February 20, 2025

This program funds projects that support transdisciplinary research teams grounded in the social and behavioral sciences, yielding empirical insights about the arts for the benefit of arts and non-arts sectors alike. Priority research topics include:

- What are measurable impacts of the arts?
- In what ways do the arts contribute to the healing and revitalization of communities?
- What is the state of access to the arts programs, services, and related opportunities for underserved groups?
- How is the U.S. arts ecosystem adapting and responding to social,

economic, and technological changes and challenges to the sector?

Funding Range: \$100,000 to \$300,000

West Virginia Department of Arts, Culture, and History: Community Arts Project Support (CAPS)

Posted: February 20, 2025

This program provides support to projects offering arts experiences to the public in West Virginia. Projects in all artistic disciplines (visual, performing, media, literary, folk, etc.) are eligible. Examples of eligible projects include presenting a concert series; presenting a traveling exhibition in a local space; public arts projects; hosting a juried exhibition of local artists; documenting a unique West Virginia tradition on film; creating new works in dance or theater; and engaging artists in producing existing works of art in theater, dance, or music.

West Virginia Department of Arts, Culture, and History: Creative Aging for Lifelong Learning (CALL)

Posted: February 20, 2025

This program provides funding for projects that teach a new skill in the visual, literary, performing, or media arts to a group of adults. Projects with a focus on the 55+ demographic will be given preference. Projects should include the following:

- Employment of a West Virginia teaching artist,
- Sequential programming to teach a new skill in the arts,
- The same group of adults in each session, and
- A culminating public event at the conclusion of the project.

Community Development

Gamma Mu Foundation: Foundation Grants

Posted: February 20, 2025

The Gamma Mu Foundation Grants address the unique challenges faced by rural and underserved populations, funding programs that promote health, education, social support, and equality. The Foundation Grants focus on three key program areas:

- **Community Support Services:** Activities proposed to meet the needs of rural communities and underserved LGBTQ+ populations, such as young people, seniors, victims of bullying, and promote empowerment and inclusivity.
- **Public Education and Research:** Initiatives designed to increase awareness and understanding of LGBTQ+ issues, foster a more inclusive environment for the community, and establish a foundation for evidence-based advocacy.
- **HIV and Health Programs:** Interventions designed to meet the needs of persons, caregivers, and families impacted by HIV and other health conditions (e.g., aging and mental health), including support and outreach activities.

Health & Nursing

Department of Health and Human Services: Behavioral and Integrative Treatment Development Program

Posted: February 20, 2025

The purpose of this program is to encourage behavioral intervention development research to test efficacy, conduct clinical trials, examine mechanisms of behavior change, determine dose-response, treatment optimization, and/or ascertain best sequencing of behavioral, combined, sequential, or integrated behavioral and pharmacological (1) drug abuse treatment interventions, including interventions for patients with comorbidities; (2) drug abuse treatment and adherence interventions; (3) drug abuse treatment and adherence interventions that utilize technologies to boost effects and increase implementability and sustainability; (4) interventions to prevent the acquisition or transmission of HIV infection among individuals in drug abuse treatment; (5) interventions to promote adherence to drug abuse treatment, HIV and addiction medications; and (6) interventions to treat substance misuse and chronic pain. Research of interest includes but is not limited to Stage I research.

National Endowment for the Humanities: Fellowships

Posted: February 20, 2025

The purpose of this program is to support individual scholars pursuing projects that embody exceptional humanistic research, rigorous analysis, and clear writing. Fellowships provide recipients with time to conduct research or produce books, monographs, peer-reviewed articles, e-books, digital materials, translations with annotations or critical apparatus, or critical editions resulting from previous research.

Proposals Due: April 9, 2025

Funding Range: \$30,000 to \$60,000

National Endowment for the Humanities: Humanities Initiatives

Posted: February 20, 2025

The National Endowment for the Humanities (NEH) Division of Education Programs is accepting applications for the five Humanities Initiatives programs. These programs strengthen the teaching and study of the humanities at institutions of higher education by developing new or improving existing humanities programs, educational resources, or coursework. Past recipients have launched a committee on manuscript, rare book, and archive studies; revised their curriculum through a week-long faculty study group examining place; and created an interactive map and database that highlights diverse regional histories and will be used in several courses.

International Opportunities

National Endowment for the Humanities: Fellowships for Advanced Social Science Research on Japan

Posted: February 20, 2025

The goals of the program are to promote Japan studies in the United States, encourage U.S.- Japanese scholarly exchange, and foster the next generation of Japan scholars in the U.S. Awards support research and writing on modern Japanese society and political economy, Japan's

international relations, and U.S.-Japan relations. These fellowships are intended for individual researchers with advanced Japanese language skills whose research will require using data, sources, documents, onsite interviews, or other direct contact in Japanese. Fellows may undertake their projects in Japan, the United States, or both, and may include work in other countries for comparative purposes. The program is a joint activity of the Japan-United States Friendship Commission (JUSFC) and NEH.

Department of State: Engaging Students in English

Posted: February 20, 2025

This program seeks proposals to strengthen bilateral ties between the United States and Luxembourg on Engaging Students in English. All programs must engage Luxembourg audiences and include a U.S. element or connection with U.S. experts that will promote increased understanding of U.S. policy and perspectives. Proposed programs can include, but are not limited to, the following:

- Strengthening specific English language skills or professional English capacity of students, such as public-speaking, debate, theater/drama.
- Enhancing and promoting the English-teaching profession and community, such as trainings, workshops, or conferences for English educators in Luxembourg.
- Holding English-language programs for underprivileged groups including but not limited to patrons of organizations, such as shelters for refugees, women, abuse victims, or children's organizations.
- Implementing educational programs such as English-language camps, academic competitions, conferences, workshops, courses, exhibits, performances, etc.
- Developing projects that share American best practices in English-language education by bringing U.S. experts to engage with students and teachers in Luxembourg.

Department of Justice: BJA FY25 Local Law Enforcement Crime Gun Intelligence Center Integration Initiative

Posted: February 20, 2025

This funding opportunity seeks to address firearm-related crime through

the establishment and expansion of Crime Gun Intelligence Centers (CGICs). This initiative is a partnership with the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) to assist local law enforcement in utilizing intelligence, technology, and community engagement to swiftly identify crime guns and their sources and effectively prosecute perpetrators.

Social & Behavioral Sciences

American Psychological Foundation: Lorraine D. Eyde Fund Grant

Posted: February 20, 2025

This grant is designed to fund research that investigates issues surrounding the ethical and professional use of psychological tests. Research proposals can focus on elements of testing such as privacy and confidentiality; quality of tests (reliability and validity); tests in employment selection; test construction; qualifications of psychologists utilizing tests; race, gender and transgender issues in testing; and inherent bias in tests and testing procedures that disproportionately impact underserved or marginalized populations. Researchers from a broad range of content areas are encouraged to apply. Grant proposals are not limited to the examples cited above and may include a substantial range of issues related to test use and ethics.

American Psychological Foundation: Visionary Grants

Posted: February 20, 2025

The American Psychological Foundation Visionary Grants seek to seed innovation through supporting research, education, and intervention projects and programs that use psychology to solve social problems in the following priority areas:

- Applying psychology to at-risk, vulnerable populations (e.g. serious mental illness, returning military, those who are incarcerated or economically disadvantaged);
- Preventing violence;
- Understanding the connection between behavior and health (e.g. wellness, diabetes, obesity);
- Understanding and eliminating stigma and prejudice (e.g. race, gender, sexual orientation, religion, age, disability, and

- socioeconomic status);
- Furthering racial equity.

STEM

National Science Foundation: Launching Early-Career Academic Pathways in the Mathematical and Physical Sciences (LEAPS-MPS)

Posted: February 20, 2025

This program supports the launch of the careers of pre-tenure faculty whose research is in Mathematical and Physical Sciences (MPS) fields at institutions that do not traditionally receive significant amounts of MPS funding, such as predominantly undergraduate institutions (PUIs). The LEAPS awards enable PIs from these institutions to initiate productive research programs and generate results useful for preparing subsequent competitive proposals to “traditional” NSF funding opportunities, such as a core program or a CAREER solicitation. A critical goal of the LEAPS-MPS Program is to develop the 21st-century STEM workforce representative of society’s full spectrum of talent by increasing the participation in STEM research of members of communities underrepresented and/or underserved in STEM and the number of members of these communities who can serve as role models.

Funding Range: \$100,000 to \$250,000
