- VI. Administrative Reports
  - Report from HR Ashley Maxey Monday, September 5, Labor Day, is a holiday for the campus. The \$1500 salary increase will be effective on September 10 for full-time benefit employees that were employed by FSU as of December 31, 2021. Employees will see this increase on the October 7 pay.
  - Report for IT Christa Kwiatkowski Employees will notice a new flag on emails which designates if email is from an external source. Employees will be receiving a letter regarding the salary increase.

  - Report from Interim President Dr. Phillips Reported that things are going well with the start of the academic year. There have been a couple of meetings of the Interim President's Council. BOG is in process of hiring a permanent president. Dr. Phillips will be meeting with employee groups on campus for "conversations" to talk about who Fairmont State University is now and who we want to become and how we get there. Campus is getting ready to kick off the United Way Campaign. Preparations are underway for Homecoming and November's Commencement.

## **Council Reports**

• <u>BOG Rep Report</u> – Jon Dodds – BOG Committees have met and two full BOG meetings since last time our Staff Council met. BOG typically doesn't have a July meeting. At the last BOG meeting Dr. Phillips talked about the Funding Formulas in place with a presentation from the state. During the Council President's meeting it was noted that the state has lost some points in our college-going rate with some counties in WV having less than a 35% college-going rate. Trying to look into some initiatives to change this. Rae Dyer was introduced as the new President of the Foundation, and she reported that the Foundation is working on the October 27 as the next annual Day of Giving. This year's goal is \$350,000. The Foundation is also in the middle of an audit. Greg Bamberger gave an update on the NCAA concussion baseline, screening, and testing for our athletes. We are conservative and hold our athletes out longer once suffering a concussion. 86% of our athletes have completed Covid testing even though there is no testing requirement in place. We are also now adequately staffed with athletic trainers. During the BOG meeting it was

reported that we are going to align the academic calendar next year, so we are not starting classes as early. Also reported that our days with cash-on-hand is at 216, compared to 194. Dr. Phillips reported that an agreement was made regarding the Aviation shared space which was going to be \$450,000 a year. By December, Pierpont Community and Technical College must inform us of their intent for the next year. In the July meeting it was reported that we are on schedule to launch the police academy this spring. Governor's Honor Academy was here for two weeks, and we will be hosting them for two more years. New BOG officers are Rusty Hutson as chair and David Goldberg as vice chair. Jason Pizatella is the secretary.

• ACCE Rep Report – John DeVault – He has accepted the offer to serve as the Student Government Advisor. They are having their elections on September 2 and 3 so SGA will be represented during our next Staff Council Meeting. John attended the ACCE meeting on August 26. HEPC spoke to them on updates specifically reviewing the economics and fiscal conditions and how it relates to salaries. They are going to do a study using external and internal validation and analysis to identify compensation issues. They also addressed the trends in higher education were the state and the nation are seeing a decline in the college-going rate. For our state, they are trying to figure out how to express the value of going to college. The third thing discussed was West Virginia's open meetings law-Article 9a specifically dealing with what a meeting is.
